

TRANSCRIPT OF TELEPHONE CONVERSATION BETWEEN
ED DUCKWORTH AND ROBIN KARR DUCKWORTH
MARCH 28, 2000

Robin: What about me seeing them Ed?

Ed: Well, uh, when do you plan on making arrangements?

Robin: I already came last November...

Ed: I know and you tried to take them without supervision and you are not going to do that, you are not going to follow the Robin rules anymore, you are going to follow the Court's rules.

Robin: Ed, there is no reason for me to have supervised visitation.

Ed: Yes there is, for starters you and your sick friends from Kansas had no intentions on returning the children that day...

Robin: They are not sick...

Ed: No... yes, they are (inaudible)

Robin: Kandy and Derek Sunderman have a K.A.L.P. group, Ed. They have a child advocacy group...

Ed: You know what Robin, they are also sick manipulative liars like you, so yeah, they do have problems you know a lot of people in their church won't even listen to them or have anything to do with them anymore because they have seen right through them...

Robin: When are you going to give this up?? Judge Pirtle was not re-elected.

Ed: I know because you got...

Robin: She was exposed, Ed. And your mother has been exposed.

Ed: Let tell you something Robin, some of your idiot friends around here who conspired with you and Brett Hall and some other people and Valeri Williams were a little too stupid to keep their mouths shut so it must be nice having a back pocket judge it is just a shame that you are not going to get to use it.

Robin: I haven't dealt with anybody.

Robin: Ed, that is so sick. This isn't a game...

Ed: Yeah, it is...

Robin: ...we are talking about two babies...

Ed: You know how biased your little story was that you and Valeri Williams did, it was so biased...

Robin: Valeri Williams is the number one news investigative reporter in the State of Texas, Ed.

Ed: No, she is not...

Robin: Channel 8 spent a fortune investigating this Ed.

Ed: No, they did not, someone else did, somebody who wanted Judge Pirtle out of office. Now they did a pretty good job, that was ignorant though because the Hall name was going to carry him through. The good ol' boys just didn't use their common sense last time when they ran against her. They finally figured out how to do it this time. But of course, the thing is, you know Robin, I don't know what kind of evidence you think you have to blackmail these people to get what you want, but it is not going to work.

Robin: What is it that you think I want, Ed?

Ed: Well, Robin, you see...

Robin: To be a mother?

Ed: All I am going to tell is to be prepared for the next 15 years because, I know that you are not going to quit until you do to me like you did to Joe Karr and his family and I'll tell you what, you are not going to do that to me and this family because we care about

these kids and we want the best for them and they are going to get it.

Robin: They are getting the best by not having a mother and not having a mother's love?

Ed: I wouldn't exactly call you a mother.

Robin: What would you call me?

Ed: Well that a good question, Robin, that's a real good question.


Robin: Ed, do you know how hateful and how mean and how angry you still sound after all this time?
